TERMS OF USE

1. Introduction

- 1.1. Please read these Terms of Use carefully. By using the Service (as defined), you agree that you have read and understood the terms in these Terms of Use which are applicable to you. These Terms of Use and the Policies (as defined) constitute a legally binding agreement ("Agreement") between you and ZEAL Systems (M) Sdn Bhd ("ZEAL") (as defined). Merchant/Food Operator shall not represent to be an agent, employee or staff of ZEAL and the foods, beverages or services provided by Merchant/Food Operator shall not be deemed to be provider by ZEAL.

2. Representations, Warranties and Undertakings

As a User, you undertake that:

- 2.1. Your use of the Service is for your own sole, personal use or, where permitted, for the use of another person who is at least twelve (12) years old ("Unaccompanied Minor").
- 2.2 You will not use the Application, Platform and/or the Software to cause nuisance, annoyance, inconvenience or make fake order;
- 2.3. You shall not intentionally or unintentionally cause or attempt to cause damage to the Merchant/Food Operators restaurant/settings/equipment;

- 2.7 You are aware that the prices of food and beverage items reflected in the Application are determined solely by the Merchant/Food Operator and are listed for information only.

- 2.8 You are aware that the Prices of foods and beverage items as reflected in the Application may, for reasons such as technical issue, typographical error or outdated product information supplied by the Merchant/Food Operator, be incorrectly reflected and in such an event ZEAL Merchant/Food Provider may cancel your order(s) and replace your order with another foods and beverages item.
- 2.9 You are responsible to collect the foods and beverages at the ordered timing and should the foods and beverages quality deteriorate due to late collection, ZEAL and the Merchant/Food Operator will not be held responsible.
- 2.10 You are aware that the ZEAL's Merchant/Food Operator shall be solely responsible for any warranty in relation to, and quality of, the food and beverage products sold to you.
- 2.11 You are responsible for ensuring that the ordering details entered by you on the Application are accurate and complete. ZEAL shall not be liable in the event of wrong order of food and beverage items that you order.
- 2.12 Where you place an order for alcohol via the Application, you warrant you and any other person for whom you are placing the order for are (i) at least twenty-one (21) years old; (ii) non-Muslim; and (iii) capable of understanding that consumption of alcohol may be harmful for your health ("MEMINUM ARAK BOLEH MEMBAHAYAKAN KESIHATAN").
- 2.13 The Merchant/Food Operator shall have the right to (i) request to be shown your ID for age verification purposes; and to, (ii) refuse to deliver any alcoholic product to any person who at the time of delivery or self-collection (A) does not appear to be at least twenty-one (21) years old and non-Muslim or (B) cannot prove that he/she is at least twenty-one (21) years old and non-Muslim or (C) is, or appears to be, under the influence of either alcohol or drugs at the time of delivery or self-collection and in such an event you agree that ZEAL and the Merchant/Food Operator shall not be liable to make any refund for payment already made to you.
